The TRP has indicated that the GST is coming soon"

# The importance of being GST ready

GST is an indirect tax that may affect all inputs and outputs of a business organisation and this tax will replace the existing sales and services tax regime. To ensure you are GST ready, a coordinated effort within the business organisation is essential. It is just not another tax issue to be left only with the Finance and Accounts Department. Rather, it is a "cross functional" issue that can affect the entire business structure and hence require input from all key business units.

CTIM is pleased to present to our members a 10-day modular course between 1 November 2012 to 1 December 2012, followed by 3-day revision session with the cooperation and support of the Royal Malaysian Customs Department. A 1-day examination will be conducted after the courses.
