#### **HIGHLIGHTS**

GST is an indirect tax that has been implemented in Malaysia since 1 April 2015. GST affects all input and output transactions of a business organisation. It is not just another tax issue to be left only with the Finance and Accounts Department. Rather, it is "crossfunctional" that affects the entire business structure and hence require input from all key business units.
