The IRB has informed the professional bodies that the first Operations Dialogue for 2010 will be held in early February 2010. In connection with this, the IRB has requested the professional bodies to submit the operational issues for discussion on or before **15 January 2010**.

The Institute hopes that members will take this opportunity to submit their views and suggestions on any issues relating to operational matters in connection with the implementation of the tax legislation. Please include your rationale for all proposals or suggestions that you feel should be raised in the Dialogue. The Technical and Public Practice Committee (TPPC) will review all suggestions and proposals and where appropriate, will include these in the memorandum for submission to IRB.

(b) Technical Issues

The TPPC also intends to arrange for a meeting with the Technical Department of IRB to discuss the various outstanding issues. Hence, comments and proposals on technical issues are also welcome from members.
