## e-Filing For Year Assessment 2015

1. Inland Revenue Board of Malaysia (IRBM) would like to inform that the submission of Income Tax Return Forms (ITRF) for the **Year of Assessment 2015** via **e-Filing** for Forms **E, BE, B, BT, P, M, MT and TF** may be done beginning March 1<sup>st</sup> 2016.
2. For BE forms, taxpayers may also submit their ITRF using smart phones or tablets via Mobile Filing application (m-Filing).
3. e-Filing and m-Filing are **FREE** applications provided by IRBM which allow taxpayers to complete, compute and submit their ITRF electronically via internet.
4. This application may be accessed via our official portal [www.hasil.gov.my](http://www.hasil.gov.my) .
5. IRBM urges all taxpayers to submit their ITRF within the stipulated period to avoid any late penalty charges being imposed upon them.

6. The deadline for **manual** ITRF submission for Year of Assessment 2015 for **E, BE, B, BT, P, M, MT** and **TF** is as follows:

<b>Form Type</b>	<b>Explanation</b>	<b>Deadline for SUBMISSION of ITRF and PAYMENT of Income Tax for the Year of Assessment 2015</b>
<b>E</b>	Return Form of Employer	March 31 <sup>st</sup> 2016
<b>BE</b>	Return Form of an Individual (Resident who <b>does not</b> carry on business)	April 30 <sup>th</sup> 2016
<b>B</b>	Return Form of an Individual (Resident who carries on business)	June 30 <sup>th</sup> 2016
<b>P</b>	Partnership Return Form	
<b>BT</b>	Return Form of a Resident Individual (Knowledge Worker / Expert Worker)	April 30 <sup>th</sup> 2016  (For those who <b>do not</b> carry on any business)
<b>M</b>	Return Form of a Non-Resident Individual	
<b>MT</b>	Return Form of a Non-Resident Individual (Knowledge Worker)	
<b>TF</b>	Return Form of an Association	June 30 <sup>th</sup> 2016  (For those who carry on any business)

8. Taxpayers who have never used the e-Filing application before this, need to apply e-Filing PIN number from IRBMs customer service counters.

9. For taxpayers who have forgotten their e-Filing password, but have a registered e-mail with IRBM, may reset their password via 'Forgot Password' through the ezHASiL portal.

10. For taxpayers without a registered e-mail with IRBM, they will need to obtain a Temporary Reactivation Code for their e-Filing password at IRBMs service counters. Kindly bring along identification card or passport for confirmation and recording purposes.

**11. Please be informed that any resetting of the e-Filing password other than the above methods will not be entertained.**

12. IRBM estimates 4.2 million submission of IRTF from various categories of taxpayers to use the e-Filing application this year compared to 4,166,177 ITRF in 2015.
