## LHDNM's MEDIA RELEASE ON E-FILING FOR YEAR OF ASSESSMENT 2015

The Inland Revenue Board of Malaysia (LHDNM) has issued a Media Release on 20 February 2016 relating to the submission of Income Tax Return Forms (ITRF) for the year of assessment (YA) 2015. Members can also refer to the Filing Programme For ITRF In The Year 2016 (Amendment 1/2016) which was reported in our e-CTIM TECH-DT 10/2016 dated 3 February 2016 in relation to this matter. The following are the salient points from the Media Release:

- 1. E-Filing of ITRF (Forms E, BE, B, BT, P, M, MT, and TF) may be done from 1 March 2016 onwards. BE forms may also be submitted via m-Filing using smart phones or tablets. The application may be accessed via the LHDNM's portal www.hasil.gov.my.
- 2. Late submission of ITRF may be subjected to late submission penalty. Click on the link below for information on the grace period for e-Filing submission.

<ul> <li>have forgotten their e-Filing password but</li></ul>	<ul> <li>reset their passwords via 'Forgot</li></ul>
have a registered email with the LHDNM	Password' through ezHASIL portal
<ul> <li>are without a registered e-mail with the LHDNM</li> </ul>	<ul> <li>obtain a Temporary Reactivation Code for their e-Filing password at the LHDNM's service counters. (Must produce IC or passport for confirmation and recording purpose.)</li> </ul>
