Public Ruling No.1/2016 on Agriculture Allowances

The Inland Revenue Board of Malaysia (LHDNM) has uploaded the <u>Public Ruling (PR) No.1/2016</u> <u>on Agriculture Allowances</u> published on 20 January 2016, on its website.

The <u>PR</u> provides guidance on tax treatment of qualifying agriculture expenditure with illustration on the computation of agriculture allowances and charges. It has also dealt with the tax treatment on receipt of a grant or subsidy.
