2016 Version of Forms EA, EC and C.P. 8D and Related Information

We refer to our <u>e-CTIM TECH-DT 95/2016</u> dated 11 November 2016 regarding amendments to Form E, CP 8D, EA and EC in respect of remuneration for the year 2016. The Institute has been informed by the Inland Revenue Board of Malaysia (LHDNM) in their <u>letter</u> dated 6 January 2017 and recent <u>announcement</u> on their website that the 2016 version of the Form EA, EC and C.P. 8D have been uploaded in the LHDNM Official Portal. The announcement also includes the following information:-

1) Form E - Submission by Employers which is a Company

The LHDNM informed that with effect from the Year of Remuneration 2016, it is obligatory for employers which are companies (including Labuan companies) to furnish the Form E (Return Form to Employer) to the LHDNM on an electronic medium or by way of electronic transmission (please access https://ez.hasil.gov.my) as required under the provision of subsection 83(1B) of the Income Tax Act (ITA) 1967.

Therefore, LHDNM will not issue the paper Form E to companies commencing from the Year of Remuneration 2016. The paper Form E submitted by a company is **not deemed received** by the LHDNM for the purposes of subsection 83(1B) of the ITA 1967.

2) Form E – Submission by Employers other than Companies.

Employers other than companies are allowed to furnish the paper Form E to the LHDNM. The Form E in PDF format will be uploaded in the LHDNM Official Portal (refer below) by 31 January 2017 and can be downloaded for submission purposes.
