# Goods and Services Tax (Zero-Rated Supply) (Amendment) Order 2017 [P.U. (A) 159/2017]

The above Order was gazetted on 31 May 2017 and is deemed to have come into operation on 1 April 2017. It amends the <u>Goods and Services Tax (Zero-Rated Supply) Order 2014 [P.U. (A) 272/2014]</u> as follows:

### 1. Paragraph 4 of the P.U. (A) 272/2014

### Classification of goods in the First Schedule

4. The classification of goods specified in the First Schedule shall comply with the Rules for the interpretation of the First Schedule to the Customs Duties Order 2012 [P.U. (A) 275/2012]

### Classification of goods

4. The classification of goods specified in the First Schedule shall comply with the General Rules for the Interpretation of the Harmonized System under the International Convention on the Harmonized Commodity Description and Coding System as specified in paragraph 4 of the Customs Duties Order 2017 [P.U. (A) 5/2017].

# 2. Appendix to the First Schedule (Supply of Goods determined as Zero-Rated Supply) of the P.U. (A) 272/2014

The amendments to the Appendix include the following:

- Changes to the format of the tariff code e.g. "0102.21 000" has been changed to "0102.21.00 00".
- Removal of the following tariff code headings:
  - 16.05 Crustaceans, molluscs and other aquatic invertebrates, prepared or preserved
  - 21.06 Food preparations not elsewhere specified or included
- Amendments under each of the tariff code headings <u>other than</u> the following tariff code headings:
  - 01.03 Live swine
  - 02.01 Meat of bovine animals, fresh or chilled
  - 02.02 Meat of bovine animals, frozen
  - 02.03 Meat of swine, fresh, chilled or frozen
  - 02.04 Meat of sheep or goats, fresh, chilled or frozen

- 49.05 Maps and hydrographic or similar charts of all kinds, including atlases, wall maps, topographical plans and globes, printed
