TAX AUDIT FRAMEWORK 2018 (AMENDMENT 1/2018)

The Inland Revenue Board of Malaysia (IRB) has recently uploaded the [Tax Audit Framework 2018 \(Amendment 1/2018\) \("Framework"\)](#). This Framework is effective from **1 April 2018** and replaces the Tax Audit Framework 2017 (Amendment 1/2017) dated 1 May 2017. It is currently available in Bahasa Malaysia only.

For ease of reference, the amendments are highlighted in yellow in the Framework. The following are some of the amendments:-

a. Paragraph 7.5.6

“ Jika pembayar cukai tidak berpuashati dengan cadangan penyelarasan cukai yang dibangkitkan, pembayar cukai boleh membuat bantahan secara rasmi dalam tempoh **21** **lapan belas (18)** hari dari tarikh surat pemberitahuan pelarasaran dengan mengemukakan maklumat tambahan dan bukti-bukti untuk menyokong bantahannya. ”

b. Paragraph 7.5.10

“ Kes audit perlu diselesaikan dalam tempoh **empat tiga (3)** bulan (**120** **90** hari calendar) dari permulaan tarikh lawatan audit. Sekiranya terdapat kes yang melebihi **4** **bulan** untuk diselesaikan **kes tidak dapat diselesaikan dalam tempoh (3) bulan**, pembayar cukai akan dimaklumkan oleh LHDNM. ”

c. Paragraph 8.3 and its sub-paragraphs

“ Ejen Cukai / Wakil Pembayar Cukai ” and “ Ejen Cukai ” have been amended to “ Ejen Cukai Berdaftar ”.

d. Paragraph 13.1

“ Seksyen **97A(2) dan** 99 hingga 102 ACP menyediakan ruang kepada pembayar cukai untuk membuat rayuan berhubung dengan taksiran yang dibangkitkan oleh LHDNM. ”
