#### **RMCD'S RESPONSE TO THE CTIM MEMORANDUM ON INDIRECT TAX ISSUES** ARISING FROM THE 2018 BUDGET SPEECH AND THE FINANCE (NO.2) BILL 2017

The Institute submitted a Memorandum on Indirect Tax Issues arising from the 2018 Budget Speech and the Finance (No.2) Bill 2017 ["Memorandum"] to the Royal Malaysian Customs Department (RMCD) on 18 December 2017.

The issues raised in the Memorandum were as follows:

- 1) Cessation of liability to be registered;
- 2) Appendix 11 of the 2018 Budget Speech GST treatment on management and maintenance services of stratified residential buildings;
- 3) Appendix 12 of the 2018 Budget Speech Review of the GST treatment for Local Authorities; and
- 4) Appendix 15 of the 2018 Budget Speech Relief from payment of GST on importation of goods under lease agreement from designated areas.

The Institute had recently received the RMCD's response to the Memorandum through their letter dated 28 February 2018.
