MOF - Updated Guidelines for the Application and Renewal of Income Tax Agent Licence (Section 153(3) of the Income Tax Act 1967)

The Ministry of Finance ("MOF") has updated the <u>Guidelines for the Application and Renewal of Income Tax Agent Licence</u> on 24 April 2019 ("Guidelines").

The updates are in relation to information that the application and renewal of income tax agent's licence is via the Malaysian Government Tax Management and Information System (MyCukai)\* online application system (previously using the "Sistem Maklumat Pengurusan Cukai" ("SMPC") online application system) and also the inclusion of three (3) more eligible academic qualifications with the names of the Universities respectively as listed in "Lampiran A1" of the Guidelines. The updates are highlighted in colour in the Guidelines for easy reference.

Members may view the updated Guidelines at the websites of the Institute and the MOF.
