JOINT TAX WORKING GROUP ON MALAYSIAN FINANCIAL REPORTING STANDARDS

Further to the Institute's <u>e-CTIM TECH-DT 27/2019</u> dated 22 March 2019, the Joint Tax Working Group on Malaysian Financial Reporting Standards ("JTWG-MFRS") has now finalised the <u>Discussion Paper (DP) on Tax Implications related to the Implementation of MFRS 15</u> <u>Revenue from Contracts with Customers</u> and submitted the said <u>DP</u> to the Tax Authorities via letter dated 16 April 2019 for their consideration.
