## <u>RMCD SPECIFIC GUIDE (OTHER GUIDE) – REVISED GST GUIDE ON TAX</u> <u>INVOICE, DEBIT NOTE, CREDIT NOTE AND RETENTION PAYMENT AFTER 1</u> <u>SEPTEMBER 2018</u>

The Royal Malaysian Customs Department ("RMCD") has issued a <u>revised GST Guide on Tax</u> <u>Invoice, Debit Note, Credit Note and Retention Payment after 1 September 2018</u> dated **29 April 2019** on its website. The updates are highlighted in colour in the Guidelines for easy reference. A summary of updates [(Appendix 1) (Amendments)] is also highlighted on page 10 of the <u>revised GST Guide</u>.

The Guidelines replace the <u>GST Guide on Tax Invoice</u>, <u>Debit Note</u>, <u>Credit Note and Retention</u> <u>Payment after 1 September 2018 dated **19 April 2019** (as reported in our <u>e-CTIM TECH-IT</u> <u>20/2019</u> dated 6 May 2019).</u>
