The Royal Malaysian Customs Department (RMCD) has released the Minutes of Customs-Private Sector Consultative Panel (CPSCP) Meeting No. 1/2019 ("Minit Mesyuarat Panel Perundangan Kastam-Swasta Bil. 1/2019") which was held on 23 May 2019. The issues raised at the meeting include the following: -
