# LHDNM – UPDATED FAQ ON TAX MATTERS DURING THE MOVEMENT CONTROL ORDER PERIOD

Further to our <u>e-CTIM TECH-DT 22/2020</u> dated 18 March 2020, the Inland Revenue Board of Malaysia (LHDNM) has updated its Frequently Asked Questions (FAQ) on Tax Matters during the Movement Control Order (MCO) Period several times to take into account clarifications sought by the Institute amongst others as well as the extensions of the MCO period by the Government. The FAQ and clarifications obtained by the Institute from the LHDNM are set out in the table below as follows:
