IFA-TA Asia Pacific Regional Tax Conference

CTIM is pleased to support the first Asia Pacific Regional Tax Conference from **2-4 April 2013**, which is organised, by IFA Singapore and the Tax Academy of Singapore

Supported by IFA US, this conference represents a unique forum for tax practitioners, tax administrators, tax policymakers and academics to discuss current key issues on Asia-Pacific taxation.

The Conference will feature leading international and regional tax experts, representatives of a number of tax authorities in the Asia-Pacific region. The keynote address will be on global trends and developments in international tax anti-avoidance. A series of post-seminar workshops on topics such as regulatory and tax developments influencing funds, investment and taxes in China, transfer pricing trends, developments, and India tax management strategies will be held.
