CTIM, was formerly known as “Malaysian Institute of Taxation (MIT)”, established on 1 October 1991.



A new name “Chartered Tax Institute of Malaysia (CTIM)” was adopted officially on 12 March 2009, governed by a council of 16 members.

# WHAT IS TAXATION?

- Tax is ‘a financial charge (not voluntary payment nor a donation) exacted pursuant to legislative authority. Failure to pay is punishable by law’.
- Tax consists of direct and indirect payments.
- All Governments use different kinds of taxes & vary the tax rate to redistribute the national wealth among individuals & classes in the population.



# HOW IS TAX USED?

Taxation finances many functions including:

- Defence;
- Enforcement of law and public order;
- Economic infrastructure;
- Social engineering;
- Welfare and public services;
- Education systems, health care and pensions;
- Public transportation;
- Energy, water and waste management.
