#### What is MyCoID

- A single source of reference for registration and transaction purposes with other relevant Government agencies.
- The number is derived from the companies' incorporation number assigned by the Companies
   Commission of Malaysia (SSM)

## History of MyColD

- The development of MyCoID started upon idea for single reference number mooted by PEMUDAH in January 2007.
- A task force headed by MOF with committee comprise of SSM, IRB, EPF, SOCSO, HRDF and Royal Malaysia Customs Department.
- After deliberation, the task force agreed to use **companies' incorporation number** as the single reference number.

#### **MyCoID Implementation Phases**

#### Phase 1

The usage of <u>company incorporation number</u> as a single source for reference, registrations and Transactions by Relevant Ministries and Government agencies

# ✓ July 2009

#### Phase 2

The establishment of a <u>system</u> to enable automatic transfer/sharing of data for simultaneous Registration with the relevant Government agencies upon incorporation at SSM



## Background Information On The World Bank's Doing Business Series

Economies are ranked on their ease of doing business, from 1 - 183, with first place being the best. A high ranking on the ease of doing business index means the <u>regulatory environment is</u> <u>conducive to the operation of business</u>. 

- 1. Objective
  - To facilitate 1 day registration at SSM and other agencies through MyCoID online portal
- 2. Scope Of Work for MyCoID gateway Implementation
  - Company Secretaries online registration and verification
  - Online Payment Gateway
  - Online e-Lodgement (prior to / after incorporation)
  - Searching of registered data through MyCoID portal
  - Printing and Emailing of Certificate of Incorporation (Borang 8 – Public Company, Borang 9 – Private Company)
  - Email and SMS Notification

#### **Overview of MyColD Components**

#### **Features in the Gateway**

- 1. Real-time inter-agency transaction services
- 2. Consolidate, track, store and audit files, request, process events, acknowledgements, receipts, and error and exceptions.
- 3. Send and receive structured and unstructured data across agencies
- 4. Process definable data formats
- 5. Allows agencies to plug-in additional business capability with minimal configuration.
- 6. Security of data transfer
- 7. Monitoring and auditing capabilities.


#### **MyCoID Main Services**

- 1. Company Secretaries online registration and verification
- 2. Online Payment Gateway for :
  - Borang 13A (Request for Availability of Name)
- 3. Online e-Lodgement (prior to incorporation) :
  - Borang 6 (Declaration of Compliance), Borang 48A (Statutory Declaration By A Director Or Promoter Before Appointment)
  - M & A (Memorandum and Articles of Association)
  - Consent letter (if any) by Company Secretary.
- 4. Online e-Lodgement (after incorporation) :
  - Borang 24 (Return of Allotment of Shares), 44 (Notice of Situation of Registered Office and of Office Hours and Particular of Changes) and 49 (Return Giving Particulars in Register of Directors, Managers and Secretaries and Change of Particulars)
- 5. Searching of registered data through MyCoID portal
- 6. Image generation in multi-tiff format for
  - Borang 6, Borang 48A
  - M & A and consent letter (if any)
- 7. Online verification by SSM officer

## **MyCoID Main Services (Cont.)**

- 8. Printing of Borang 9 (Certificate of Incorporation of Private Company), if the application is approved
- 9. Email of Borang 9 softcopy via email to applicant
- 10. Email and SMS notification for
  - Required subsequent task i.e. further course of action such as collecting Borang 9 or statutory book
  - unsuccessful application
- 11. To validate automatically with Jabatan Pendaftaran Negara's ALIS for MyID (Malaysians only) when submitting Borang 48A and 49 to SSM
- 12. To integrate with LHDN for e-Stamping (exploratory stage)
- Payment Gateway integration to SSM's fee structure of the newly incorporated company including fees for stamp, company seal and statutory books, ALIS, Stamping and also for MyCoID fees for updated information

#### **MyCoID** Propose Framework



#### MyCoID Main Services (Agency)

- 1. Received registration information specified to the agency through integration server
- 2. Sending of "Processing" status to MyCoID
- 3. Search of initial registered data through MyCoID portal
- 4. Search of initial registered data through local database installed at server located at Agency's environment
