1. Following the issuance of Form R31, the Institute (together with the professional bodies) submitted a letter to the Director General of Inland Revenue recently to convey the difficulties faced by practitioners with regard to the new Form R31 and related issues.

The Inland Revenue Board (IRB) issued a <u>letter on 9 April 2008</u> to MIT and the professional bodies informing that the new filing arrangement of the Form R31 will be as follows:

Type of Companies	Deadline for Filing
Companies with year end on or before 30 September 2007 Companies with year end on 31 October 2007 Companies with year end on 30 November 2007	30 April 2008 31 May 2008
The leastiful 111	30 June 2008

The Institute will continue to seek additional clarifications on other related matters connected to Form R31 and will keep members informed of further developments.

2. In the <u>letter dated 9 April 2008</u>, the IRB also informed that the PDF format of Forms C and R for the year of assessment 2008 is available for download from the <u>website</u>.

A. Submission of Form R31

The Institute (together with the other professional bodies) had submitted an appeal to the Director General of Inland Revenue recently for an extension of time to file Form R31 (especially with regard to the busy month of April 2008 for practitioners) and to seek clarifications on some related issues. The Inland Revenue Board (IRB) has replied via its Letter dated 16 April 2008 as follows:

1. The IRB does not agree to allow an extension other than what had been highlighted in their letter of <u>9 April 2008</u>. (Refer our <u>e-MIT No. 11/2008</u>).

As such, the filing deadlines for Form R31 are as follows:

Type of Companies	Deadline for Filing
Companies with year end on or before 30 September 2007	30 April 2008
Companies with year end on 31 October 2007	31 May 2008
Companies with year end on 30 November 2007	30 June 2008

2. With regard to the requirement to file Form R31 for companies which did not declare dividends during the relevant period, the IRB informed that the law will be changed to require every company whose basis period ends on a date other than 31 December 2007, to file the Form R31. It is unclear as to when the law would be amended.

The Institute will point out to the IRB that the approach to seek companies to file the Form R31 when there is no legal requirement to do so, is not an appropriate step. Any filing of a form should be required only when there is a legal requirement.

For a company whose basis period ends on 31 December, there is no need to file the Form R31 even if it was issued with the said form.

3. For advance tax payments made on or before 7 September 2007 in respect of tax installments due and payable after 31 December 2007 (Item A2b of Form R31), the IRB is of the view that tax paid (for non-31 December year end companies) in the context of Section 39 of the Finance Act 2007 means payments for tax liability which arises from the first day of the basis period for the year of assessment 2008 to 31 December 2007.

The concession granted by the Ministry of Finance is to allow the tax paid in respect of tax liability (payable by way of instalments) due after 31 December 2007 to be included in the Section 108 account, provided the advance payment was made on or before 7 September 2007.

4. The IRB confirmed that only Malaysian resident companies and Singapore resident companies subject to Malaysian tax with a basis period ending on a day other than 31 December need to file Form R31.

B. e-Filing System for Tax agents

The IRB has introduced e-filing for tax agents this year. Members are encouraged to try out the e-filing system so as to familiarize themselves with the system.

The Institute is in the process of collating issues faced by users of the e-filing system (including e-filing for individual taxpayers) and will forward these issues as well as possible recommendation to the IRB with the view of improving the effectiveness and efficiency of next year's e-filing programme. In this respect, you are requested to submit your comments and suggestions to kslim@mit.org.my and technical@mit.org.my on or before 30 April 2008. You are kindly required to provide a brief explanation of the issues and the suggestions, if any, for improvement. Your contribution will certainly assist in making filing easier next year.

- 2. The IRB has informed all professional bodies (via its letter dated 3 June 2008) that many PDF format tax return forms submitted by tax agents do not follow specifications and this causes problems and delays in the processing of these tax returns. The IRB has stated that such return forms will not be accepted by the IRB.
 - Members are reminded that the PDF format tax return forms must be used in accordance with the specifications stated. The IRB also encourages tax agents to submit tax returns via the efiling mode or by way of completing the original tax return form.
- 3. The IRB has also informed that the Mandarin translation of the Form B for the year of assessment 2007 has been uploaded on the IRB's website for the purpose of reference only. It cannot be used for filing purposes.

1. Gifts of New Personal Computers and Monthly Broadband Subscription Fee to Employees

Please be informed that effective from year of assessment 2008 till year of assessment 2010, the cost of a new personal computer OR monthly broadband subscription fee registered in the name of the employer is

- a) allowed a deduction in ascertaining the adjusted business income of the employer under the Income Tax (Deduction for Gifts of New Personal Computers and Monthly Broadband Subscription Fee to Employees) Rules 2008 [PU(A) No. 192/2008], and
- b) exempted from income tax in the hands of the employee under the Income Tax (Exemption) (No. 4) Order 2004[PU(A) No. 191/2008].
- 2. Income Tax (Accelerated Capital Allowance) (Security Control Equipment or Monitor Equipment) Rules 2008 [PU(A) No. 205/2008]

Effective from year of assessment 2008 till year of assessment 2012, capital expenditure incurred by a resident company incorporated under the Malaysian Companies Act 1965 in relation to installation of

- a) any **security control equipment** for a factory of the company, provided that the company is approved under Industrial Co-ordination Act 1975; and
- b) any monitor equipment for
 - i) a container lorry of the company bearing Carrier Licence A, or
 - ii) a general cargo lorry of the company bearing Carrier Licence A or C

shall be allowed an initial allowance of 20% and an **annual allowance of 80%**. However, if the assets are disposed of within two years from the date of acquisition, the capital allowances so allowed shall be withdrawn in the year of disposal. The type of assets which qualify are specified in the Rules.

This incentive shall not apply to company in the basis period for a year of assessment in which the company has been granted any incentives under the Promotion of Investments Act 1986 or has been granted Reinvestment Allowance under Schedule 7A of Income Tax Act 1967.

3. Stamp Duty (Remission) Order 2008 [PU(A) No. 211/2008]

For a sale and purchase agreement executed between 8 September 2007 and 31 December 2010 (both days inclusive) in respect of one unit of a residential property purchased by an individual costing not more than RM250,000, 50% of the stamp duty shall be remitted.

4. Service Tax (Amendment) Regulations 2008 [PU(A) No. 216/2008]

The annual sales turnover threshold for restaurants located outside hotels, including food courts (Group C) has been increased from RM300,000 to RM3,000,000 with effect from 1 July 2008. Consequently, many restaurants and food courts are not subject to service tax with effect from 1 July 2008.
