1. New Guidelines for the Application and Renewal of Tax Agent's License (Guidelines)

First and foremost, I would like to thank members of MIT for responding and giving us their thoughts on the Guidelines.

After going through your notes, I found that generally members of MIT have the same concerns with regards to the Guidelines.

Having collated the issues sent in by members, I have set out in a summary form, the main issues, as follows:

- (i) There should be no requirement for an interview when renewing a Section 153 license.
- (ii) There should be no requirement to provide a list of cases when applying to renew a Section 153 license.
- (iii) A committee should be formed to assess the applications (both new and renewals) and for transparency, this committee must have representation from the profession.

Our approach in drafting MIT's memorandum to Ministry of Finance (MOF) is to set out very simply the main areas of concern, as too much information may confuse the issue.

The memorandum (in the form of letters) which was sent to MOF on Friday, 20 January 2006, very clearly sets out the issues above. A copy of the memorandum may be found on MIT's website at www.mit.org.my. Comments raised in your emails pertaining to the Guidelines will be used in support of our arguments when we meet with MOF to discuss the matter.

As for the Continuing Professional Development (CPD), many issues have been raised but the most glaring it would seem is the need for a more diversified programme. Though a lot of pressure is being asserted on MOF to widen the number of CPD providers, currently only MIA, MIT, LHDN and MOF programmes are recognised for CPD points. As such MIT will strive to schedule sufficient training programmes for its members.

On behalf of MIT, I would like to assure members that the Council will do its utmost to protect the rights of MIT members and we will keep you posted on any information obtained from MOF / Government on this matter.
