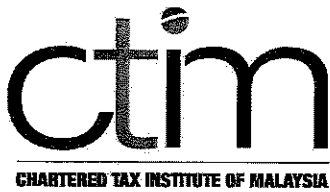

1. **Double Taxation Relief (The Government of the Republic of Seychelles)(Amendment) Order 2010 [P.U.(A) 286/2010]**

Double Taxation Relief (The Government of the State of Kuwait)(Amendment) Order 2010 [P.U.(A) 287/2010]

The protocols amending the double taxation agreements between Malaysia and Republic of Seychelles, and between Malaysia and Kuwait have been gazetted on 26 August 2010. The amendments pertain to Acticle 26 relating to Exchange of Information.

2. **Income Tax (Special Treatment on Interest on Housing Loan)(Amendment) Regulations 2010 [P.U.(A) 288/2010]**

The Order amends Regulation 5 of the *Income Tax (Special Treatment on Interest on Housing Loan) Regulations 2009 [P.U.(A) 109/2009]* and is retrospective from year of assessment 2009 and subsequent years of assessment.

A moratorium of housing loan interest approved by a bank or financial institution shall not constitute the gross income of that bank or financial institution. Previously, such treatment is applicable where the employment of the individual to whom the housing loan was granted has been terminated pursuant to a separation scheme or retrenchment on or after 1 July 2008 and the housing loan was granted prior to the termination of the employment.

The conditions are now relaxed by this Order to include the individual who is carrying on a business, the individual whose monthly income has been reduced due to a salary cut or in the case of joint loan, the employment of the individual's spouse has been terminated on or after 1 July 2008, as well as the individual who is a guarantor under a housing loan where the employment of the guarantor is terminated pursuant to a separation scheme or retrenchment on or after 1 July 2008. For the individual who is carrying on a business, the housing loan was granted before 10 March 2009.

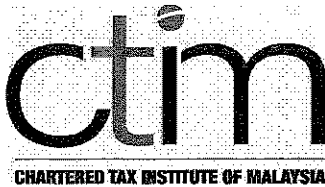

1. Malaysian Goods and Services Tax Portal

The Ministry of Finance, together with the Royal Malaysian Customs (RMC) have recently launched the new Malaysian Goods and Services Tax (GST) Portal.

The portal is designed to provide information as well as free online services in respect of the proposed GST to consumers, industry players and the general public.

2. Ratification of the double tax agreement (DTA) between Malaysia and Brunei

The DTA between Malaysia and Brunei for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income signed on 5 August 2009 was ratified on 17 June 2010.

In accordance with Article 28, the DTA is effective for the years of assessment beginning on or after 1 January 2011 for income tax and withholding tax, whilst for petroleum income tax, it is effective for the years of assessment beginning on or after 1 January 2012.

1. **Double Taxation Relief (The Government of the Republic of San Marino) Order 2010. [P.U.(A) 302/2010]**

The above agreement was gazetted on 2 September 2010. The double taxation agreement has yet to come into force.

2. **Double Taxation Relief (The Government of the United Kingdom of Great Britain and Northern Ireland)(Amendment) Order 2010 [P.U.(A) 322/2010]**

The protocols amending the double taxation agreement between Malaysia and the United Kingdom of Great Britain and Northern Ireland have been gazetted on 27 September 2010. The amendments pertain to Article 28 relating to Exchange of Information. The protocols have not entered into force.

3. **Loans Guarantee (Bodies Corporate) (Remission of Tax and Stamp Duty) (No. 2) Order 2010. [P.U.(A).331/2010]**

The remission of tax in relation to income derived from the Islamic Medium Term Note issued by Pengurusan Air SPV Berhad, and remission of stamp duty in respect of any agreement in relation to the guarantee, is provided for under the Order which was gazetted on 30 September 2010.

4. **Income Tax (Determination of Knowledge Worker, Qualified Activity and Specified Region) Rules 2010) [P.U.(A) 344/2010]**

These rules dated 29 September 2010 provide the definitions of "knowledge worker", "qualified activity", "specified region" and "designated company" in respect of the Iskandar Development Region.

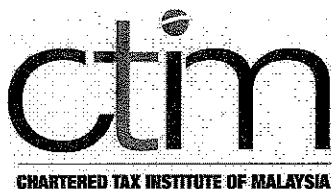
