Revised - IRB Operating Hours during Ramadhan (Fasting Month)

The Inland Revenue Board (IRB) has uploaded a media release to their website on 30 June 2014 regarding their operating hours during the fasting month. The IRB's operating hours during the month of Ramadhan will be from 7.30 a.m. to 5.00 p.m. In order not to affect service hours, the IRB will shorten its afternoon break time from 1 hour to 30 minutes.

The operating hours for the Branches and Revenue Service Center, the Urban Transformation Centre (UTC) and the Contact Centre of the IRB are set-out in the table below.
