[EXCISE DUTIES \(EXEMPTION\) \(AMENDMENT\) ORDER 2014 \[P.U. \(A\) 225/2014\]](#)

The above order was gazetted on 6 August 2014 and comes into operation on 7 August 2014. It amends Part 1 of the Schedule in the [Excise Duties \(Exemption\) Order 2013 \[P.U. \(A\) 379/2013\]](#) by inserting the word “**imported**” after the word “*excluding*”, in column (3): Goods exempted, in relation to the following:

Item (7): Person Exempted – All Federal or State Government Department

Item (8): Person Exempted – Any person approved by the Director General
