Indirect Taxation**Update on Goods and Services Tax (GST) General Guide**

The Royal Malaysian Customs (RMC) has issued two updates to the GST General Guide since 23 December 2015. The latest updated [GST General Guide - revised as at 1 July 2016](#) was uploaded on 4 July 2016. The changes relate to the following:

- **Penalty for Late Payment of Tax**
- **Transfer Of Going Concern (TOGC)**
 - **Registration for Transfer of Business as a Going Concern**
 - **Transfer of business Asset as a TOGC.**
- **Imported Services**
 - **Time of Supply & Exceptions to the General Rules (Para 88)**
 - **Value of Supply**
- **Others**
 - **Mechanism to Claim Input Tax**
 - **Discount Vouchers**
 - **Warehousing Scheme**
 - **Corporate Social Responsibility**
 - **Amount of Tax Due and Payable to the Director General**
