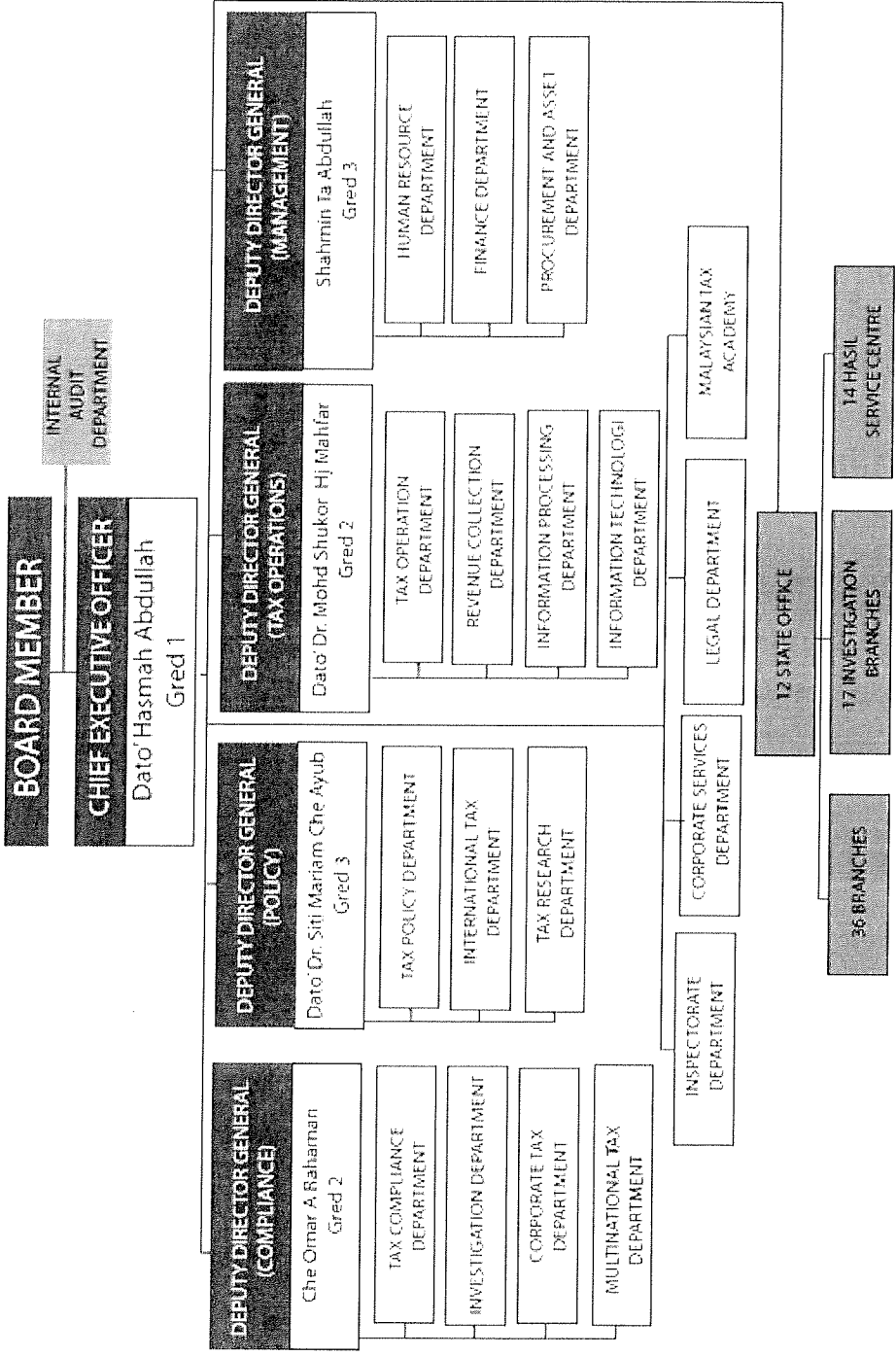




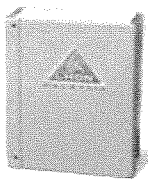
ORGANISATION CHART
