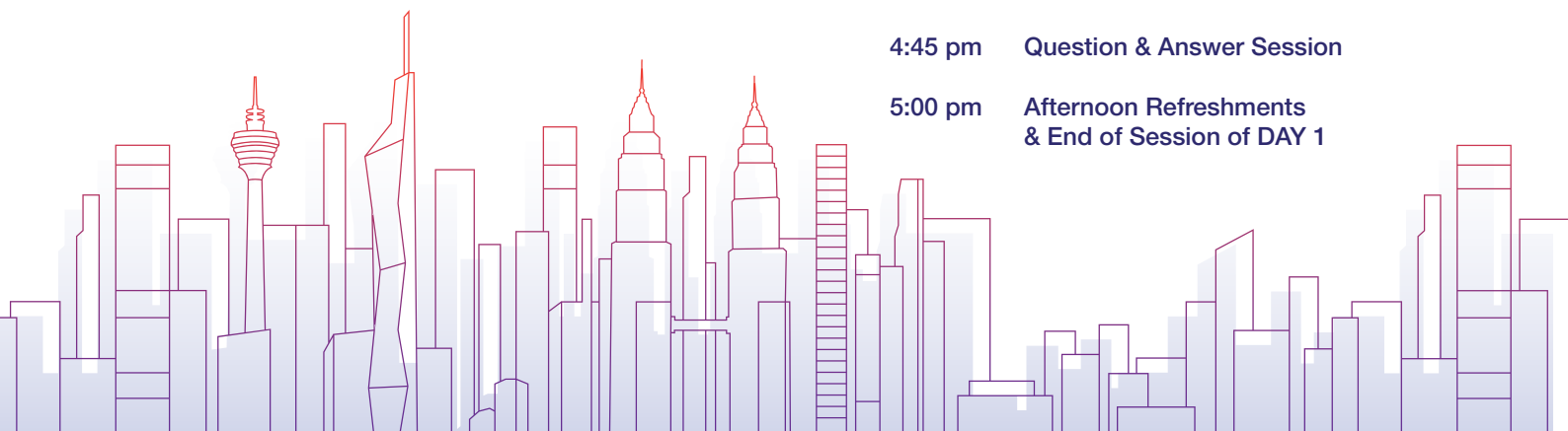

PROFILE



Datuk Johan bin Mahmood Merican is the Secretary General of Treasury, Ministry of Finance, appointed in February 2023. He was previously the Deputy Secretary General (Policy) and National Budget Director at the Ministry of Finance. Prior to that, Datuk Johan Mahmood Merican held the position of Deputy Director General (Human Capital) at the Economy Planning Unit and Chief Executive Officer of Talent Corporation Malaysia. He also served 9 years in the private sector in corporate finance and accounting. He currently serves on the Boards of Bintulu Port Holding Berhad, Samalaju Industrial Port Sdn Bhd, Malaysia Airports Holding Berhad, Kumpulan Wang Simpanan Pekerja, Pengurusan Aset Air Berhad, Govco Holdings Berhad, MyDIGITAL Corporation, Pembiayaan PFI Sdn Bhd, University Malaya, Malaysia and Chairman of Inland Revenue Board of Malaysia.



Datuk Dr Abu Tariq bin Jamaluddin is presently the Chief Executive Officer of the Inland Revenue Board of Malaysia. Prior to his current post, he was the Deputy Chief Executive Officer (Compliance), having oversight of the investigation, audit and intelligence arms of the Board. A qualified lawyer and having served the Board for over 27 years, he has extensive advisory, litigation and drafting experience in all aspects of tax laws and has represented the Director General of Inland Revenue before the Special Commissioners of Income Tax and at the superior courts of Malaysia in many landmark cases. Datuk Abu Tariq was instrumental in setting-up the Dispute Resolution Panel, an initiative introduced to expedite tax appeals by taxpayers and was its first Chairman. He is also technically experienced having been involved significantly since 1997 in the drafting of laws to cater to Malaysia's annual national budget. In pursuit of the Board's mission and objectives, he advocates a fair, independent and transparent approach to activities under his purview. He is often seen as a speaker and panelist on the national and international taxation conferences' circuit.



Soh Lian Seng is currently the President of the Chartered Tax Institute of Malaysia and leads the Tax practice at KPMG in Malaysia following his appointment to the firm's Executive Committee leadership on 1 January 2022. As KPMG's Head of Tax in Malaysia, he brings over 33 years of professional acumen and capabilities to help clients navigate the most complex business challenges and transformation projects that tax leaders face. Lian Seng pioneered the Malaysian firm's Tax Dispute Resolution service unit in 1999 and has since built a reputation within the Malaysia tax fraternity for his negotiation and problem-solving expertise in challenging tax audit and investigation cases. Under his leadership, KPMG Tax Services in Malaysia was named the 2019 Tax Dispute & Resolution Firm of the Year by the International Tax Review. In the course of his career, Lian Seng has developed strong and mutually respected ties with various authorities including the Inland Revenue Board of Malaysia, the Tax Policy Division of the Ministry of Finance, and other government agencies such as the Malaysian Investment Development Authority (MIDA) and the Malaysia Digital Economy Corporation (MDEC). He has also contributed to the development of tax laws and regulations in Malaysia. Lian Seng is a licensed tax agent approved by the Ministry of Finance under section 153 of Income Tax Act, 1967. He is certified as a Fellow Member of CTIM, an associate member of the Institute of Internal Auditors, Malaysia (IIAM) and an affiliate member of the Malaysian Institute of Chartered Secretaries and Administrators (MAICSA).



John Patrick Antonsamy currently serves as the Under-Secretary Tax Division at the Ministry of Finance. Previously, he was Deputy Director General II at the Public-Private Partnership Unit under the Prime Minister's Department. His main roles and functions include chairing the Project Steering Committee to plan, coordinate, evaluate, and negotiate Public Private Partnership projects. He has served in the Government Administrative and Diplomatic Service for the last 28 years in several roles. He served in the Ministry of Finance in the Budget Division as well as the Economics and International Relations Division. His area of work involved Malaysia's participation in finance-related areas in ASEAN, APEC and ASEM as well as international organisations such as the World Bank, IMF, ADB, and WTO. Besides that, he has also served in the Tax Division and was responsible for FTA negotiations on tax issues, the WTO Trade Facilitation Agreement as well as OECD and Multilateral Tax Issues. He was involved in the formulation of tax incentives, examining Services Sector and Petroleum Tax Exemptions as well as representing the Ministry of Finance in the MIDA National Committee on Investments. During his service at the Ministry of International Trade and Industry, he was the Senior Director of Strategic Planning Division responsible for planning the Industrial Masterplan. In addition to that, he took on the role of Lead Negotiator for Market Access under the TransPacific Partnership Agreement (TPPA) responsible for market access for goods. He has also served as Malaysia's Chief Negotiator for ASEAN-China Free Trade Agreement (ACFTA).



Abdul Muheet Chowdhary is Senior Programme Officer and leads the South Centre Tax Initiative (SCTI) of the South Centre, a Geneva-based intergovernmental policy research think-tank of developing countries. He is a member of the United Nations Tax Committee's Subcommittee on Wealth and Solidarity Taxes, a member of the Base Erosion and Profit Shifting (BEPS) Monitoring Group and is on the Steering Group of the Independent Commission for Reform of International Corporate Taxation (ICRICT). Previously, he served in India's Ministry of External Affairs where he was in the Policy Planning and Research Division specialising in economic strategy. He was formerly a consultant to the United Nations and also worked as a legislative aide in the Parliament of India, specialising in tax and financial law.

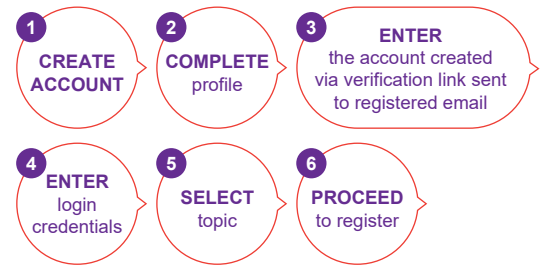
